Traffic Management

(Registered Training Organisation Nara Training & Assessing 4518 will be the RTO issuing this qualification)

Main Roads WA requires all persons intending to undertake an event or conduct works that may impact on traffic to hold a relevant and current traffic management certificate of accreditation.

This 3 day course provides participants with the theory and practical skills to implement a traffic management plan (planning, preparing, and setting out, monitoring and closing down the traffic guidance scheme and cleaning up) controlling traffic with a stop-slow bat in accordance with Main Roads WA Standards.

Participants will complete units of competency

- RIIWHS302D Implement a traffic management plan
- RIIWHS205D Control traffic with stop-slow bat
- RIICOM201D Communication in the workplace
- RIIWHS201D Work safely and follow WHS policies and procedures

On day of course:-

- Please bring photo ID
- Wear appropriate protective clothing & footwear, no thongs/singlets.
- You must be a minimum of 18 years of age.

Pre-requisite:

- Hold or have held a driver's licence
- Have a valid WorkSafe WA White card or Blue card.

Upon successful completion of the course, you will be issued with a Statement of Attainment, MRWA photo ID (valid for 3 years) and MRWA Certificate of Accreditation


