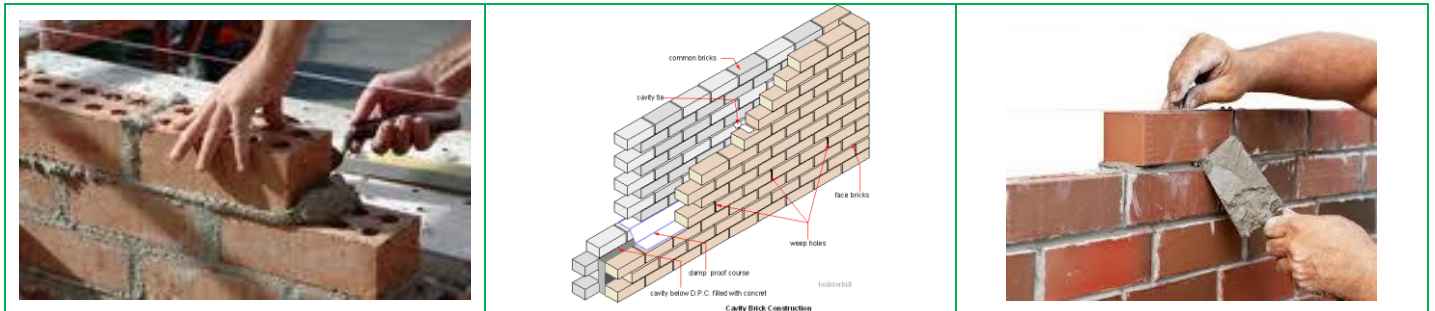

BCA Brickwork Requirements
