- Fully completed entry form for each apprentice (including payment).
- A brief description of your company.
- A detailed description addressing the judging criteria listed above of the apprentice.
- Supporting documentation ie copies of results, awards, reference of the apprentice.
- Two (2) photos on CD of the apprentice - one head shot and one on-site (resolution 300dpi, 210mm x 297mm in .jpeg format)

The winner of the Master Builders Regional Apprentice of the Year is eligible for automatic entry into the Master Builders Best Regional Apprentice Award if they are directly employed by a Master Builders member and not through a Group Training Company. (Unless that Group Training Company is a member in their own right)
